Dragonfly Report


<u>Final 2016/2017 Report Pygmy Snaketail and Riverine Clubtail survey Goulais River,</u> <u>Algoma</u>

The Sault Ste. Marie Field Naturalist with the cooperation and guidance of the local MNRF office completed the first year of a two-year project to collect and identify dragonfly exuviae found along the banks of the Goulais River. Three Transects were chosen with three sampling sites for each transect. The transects were identified by Arthropod Zoologist Colin Jones with the help of Derek Goertz Biologist for MNRF. Over a 21-day period in June from June 6 to June 26, a team of Sault Naturalists would drive up to the transects and gather exuviae present in a 1 metre zone from the waters edge at each site. The protocol for the sampling was included in our Interim Report in October. The exuviae were then transferred to the lab in Sault College with the cooperation of Elisa Muito and Jerry Zelinski professors in the Natural Environment and Outdoor program at Sault College. Using Sault College's high powered identification microscopes, a team consisting of Val Walker (retired Biologist, former professor and chair of the Natural Environment Program Sault College) and Jerry Zelinski (Entomologist and professor in the Natural Environment and Outdoor program at Sault College) identified and catalogue 326 of the 346 specimens collected over the 21 day collection period. 20 specimens where too incomplete to identify. To facilitate this endeavour, they donated their time (240 hours of lab time) in kind to the project allowing us to order necessary collection trays and other materials required for proper storage and identification of each specimen.









The results of the collection can be seen on the chart below.

Dragonfly specimen identification June 2016 Goulais River



With the partnership with Colin Jones our identification team sent samples from our collection for further identification to determine if the identified species were correct. The results were returned in the affirmative. As can be seen we have not found any Pygmy snaketail or Riverine



clubtail. Perhaps this year's collection will be different. We hope that the data we collected will help in the overall monitoring of the species of dragonflies from the Goulais River area.

We will discuss with Derek Goertz and Colin Jones our results and determine any changes to our strategies for collection of exuviae in June of this year. We underestimated the time in which it would take us to do the collection. We would be on the road at 9:00AM and return to the city by 3:30-4:00 PM which made for a long day. We would stop for lunch for a short while beside the river which except for the odd biting insect was enjoyable.

Our goal to collect the exuviae at the expert identified sites was achieved by the active participation of 12 different members of the Sault Ste. Marie Field Naturalists along with some students from Sault College over a three week period. Some of the sites were somewhat difficult to reach and it was a physical challenge for our members over the 21 days that we collected specimens.

Fortunately, the weather was not severe and our project was completed with ill effects. We look forward to the 2017 year collecting exercise with the hope that we will find the elusive Pygmy Snaketail and Riverine Clubtail.
