ATTACHMENT "C" - West End Creeks Meeting Report

January 31, 2018

PARTICIPANTS

- Director of Planning and Enterprise Services, Don McConnell,
- SSM Regional Conservation Authority General Manager, Rhonda Bateman
- Ron, Val, Chuck and Jerry of the Sault Naturalists.

BACKGROUND

- West End Creeks are primarily managed to minimize flooding
- Some opportunity to increase "naturalization" of these creeks
- Some opportunity to increase recreation opportunities adjacent to these creeks

City Responsibilities

- Ensuring ground water recharge areas are part of new developments.
- Developing Trails through STAC
 - Has funding for bike trails, looking to expand west across these creeks
- Maintaining HUB trail where it has an easement for the trail
- Leading initiative for "Future SSM Plan" which has four pillars; Economic, Social Equity, Arts and Culture, and Environment (see FutureSSM.com).
- City had considered developing park land at Mouth of Fort Creek (between Casino and River), but is concerned about appearance of creek (heavy siltation). Has been told Fort Creek is critical fish habitat

SSMRCA

- Is a major landowner on many sections of the west end creeks
- Open to more naturalization on stream lands outside of stream flow basin and outside of access routes for their maintenance vehicle
- Rhonda to check with other CA's regarding costs & approaches to naturalization
- Open to expanding community involvement projects (e.g. expand their tree planting)
- Needs watershed plans to help identify what gets done where.
- Can ask for funds for watershed plans under WECI (Water & Erosion Control Infrastructure). Is considering looking for a Graduate student to do Watershed plan and then WECI funding to implement.

Opportunity for Sault Naturalist Club

- Assisting SSMRCA in applying for additional funding for tree planting (currently TD Friend of the Environment Foundation)
- Assist SSMRCA in planting trees
- Choose one current metal weir in disrepair and propose a more natural alternative
- Clean up a section of Creek (e.g. Central Creek Second Line to Wallace Terrace)
- Provide support for SSMRCA's application for funds for a Watershed Plan
- Provide information to CA's channel maintenance schedule to reduce the impact on birds during their critical nesting periods within the flood channels (Val)
