4. BUSINESS ARISING FROM THE MINUTES

- a) Milkweed Protection (St. Joe's Island) results
 - Success protecting Milkweeds,
 - not many Monarch butterflies visible, but a few larvae observed
 - Not a lot of sign of browsing by Monarch caterpillars
 - Good size plants in ditch, younger/smaller plants nearer road.
 - A lot of Milkweed in fields and along roads.

MOTION: Ron to contact Jocelyn Township, Hilton Township and MTO to thank them for not mowing milkweed in these areas and ask them for continued support. Proposed by Chuck, seconded by Carter. Motion carried.

- b) Creek Revitalization Meeting Results
 - Meetings are discouraging; since CA is focusing on flood mandate. An
 Engineering study is needed to assess the impact of new vegetation on
 water flow prior to proceeding with naturalization of the creek ways. CA
 does not have funding for such a study this year.
 - CA repeated commitment to do some tree planting in two locations (Base Line west of Allen Side Rd and Goulais Avenue near Korah Avenue)
 - City to provide names of two land owners who need to be approached if a trail is to be built behind Korah Collegiate
 - City has an Environmental Advisory Committee, Chair is David Nanang (GLFC); another potential contact and ally

 - July 1st. Thanks to Chuck and Ron for manning the station. The event was good public relations for our club.

 - Parks Canada likes the list. List is being used by visitors to the park.
