 - Ontario's Environmental Bill or Rights registry is now named the Environmental Registry of Ontario.
 - Bill 66: Restoring Ontario's Competitiveness Act, 2018 is up for review until January 20th
 - Ontario Nature is concerned that this streamlining of regulations will allow for encroachment and development on previously protected areas (e.g. Newmarket and Oak Ridges moraine).
