4. BUSINESS ARISING FROM THE MINUTES

 - Short term repair need for Pumpkin Pt Road (about \$200 for temporary repair)

- Committee is working on full Report
- Costs are going to be high. For Example
- Echo Bay is spending \$77,000 to repair a 1000 foot section of the Loonie Marsh boardwalk.
- The bird watching platform on Lake Street in Echo Bay needs 100 feet of raised boardwalk to be accessible; that alone could be a \$7,000.00 expense. (alternatively could dump loads of gravel to raise path out of water)
- The Pine Street Marina platform is stable. Sign can be replaced \$500
- St Mary Island platform decision,
 - Parks Canada agreed not to tear down immediately
 - work needed on; stair, platform and railing
 - Soo College may be able to do work
 - Parks Canada will asks for a license of occupation for \$100.00 per year on a new structure.
 - Need decision soon whether to repair or inform Parks Canada they can proceed with removal.

MOTION: To inform Parks Canada that they can proceed with removal of the platform. Proposed by Ron and seconded by Carter **Motion carried**
