APPENDIX B FMZ 10 Advisory Council Meeting Minutes Summary – November 13, 2019

Proposed Regulation Change: LAKE TROUT

Historical LT angling regulations:

Pre 2008: Limit: 3 fish; Season: Jan1 – Sept 30

2008–Present: Limit: (S)-2 fish any size (C)-1 fish; Size: only 1 fish > 40 cm; Season: Jan 1- Labour Day

Since 2008:

- 1. Abundance of $LT \ge 350$ mm (recruitment size) has increased 17% (not statistically significant)
- 2. Abundance of $LT \ge 400 \text{ mm}$ (mature) has increased 19% (not statistically significant)
- 3. Number of LT Age Classes has increased by 2 (statistically significant)
- 4. Mean Average Age of $LT \ge 350$ mm (recruitment size) has increased from 11 years to 12.5 years (statistically significant)
- 5. Pre Recruitment (< 350 mm) Growth Rate has decreased significantly in LT

Option 1: Retain current recreational angling regulation as follows: Season:

- Open Jan 1- Labour Day
- Catch and Possession Limits:
 - Sport Fishing Licence 2;
 - Conservation Licence 1;
 - Size Limit not more than 1 > 40 cm

Counsel Recommendation

Option 1: Maintain Status Quo

Proposed Regulation Change: BROOK TROUT

Much discussion on BT Management Issues:

- 1. Season Limit harvest, protect pre-spawn, align with LT season
- 2. Size Limit maintain population structure, provide trophy fishery opportunity
- 3. Bait Restriction limit the introduction of other species (Rock Bass, YP other sunfish)
- 4. Access/Operations (Land Use Planning) reduce angling pressure, reduce occurrence of introductions, reduce habitat pressures

BT – Management Action

- 1. Extend LT Benchmark to BT
- 2. Access and Harvest restrictions:
 - Zone 1 (120m); no harvest, no new roads
 - Zone 2 (280m); no new roads, skid trails only
 - Zone 3 (600m); operational (temporary) roads only

Option 1: Retain current recreational angling regulation as follows: Season:

• Jan 1 to Sept 30

Catch and Possession Limits:

- Sport Fishing Licence (S) 5
- Conservation Licence (C) 2

No vote yet on whether to or how to change regulation for BT...deferred to next meeting Jan 08, 2020
